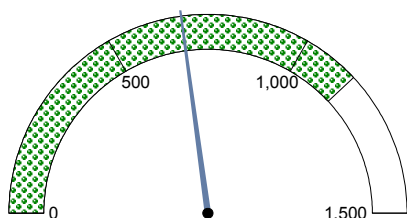


WILL ROGERS HS**No Child Left Behind Act Annual Report Card 2010-2011****Academic Performance Index (API) and Accountability Data**

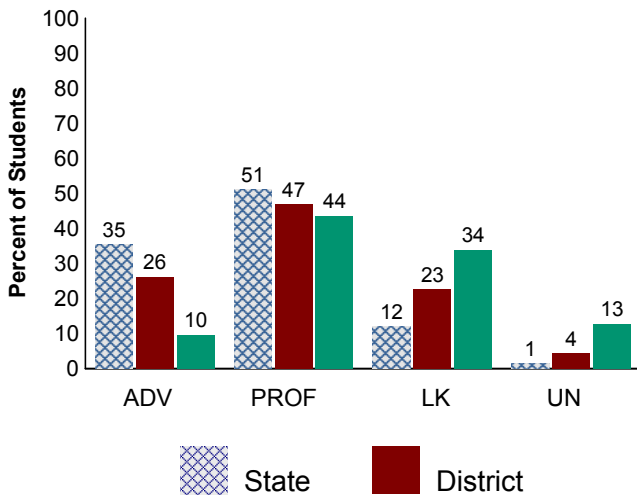

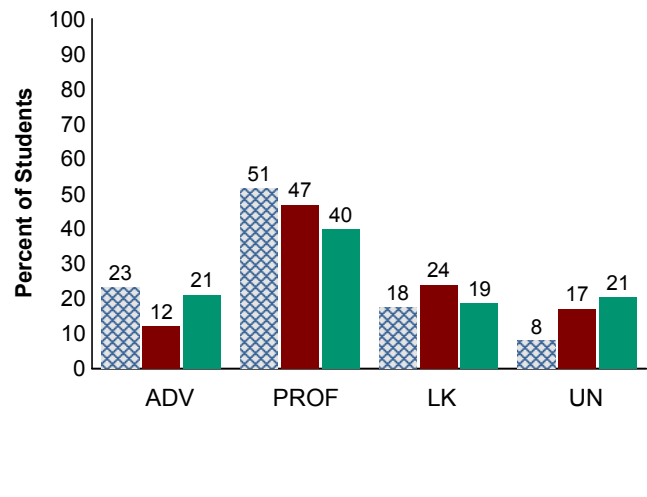
State and District English II Results

State and District Algebra I Results

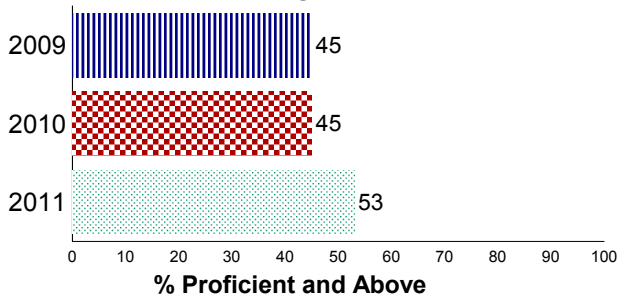

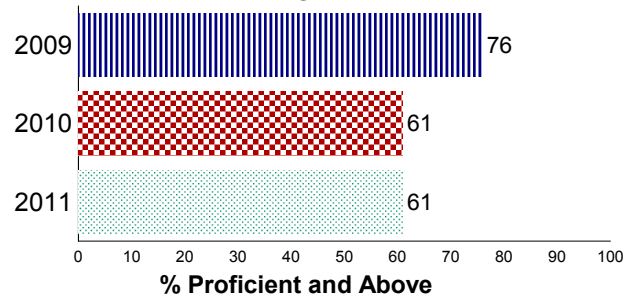
