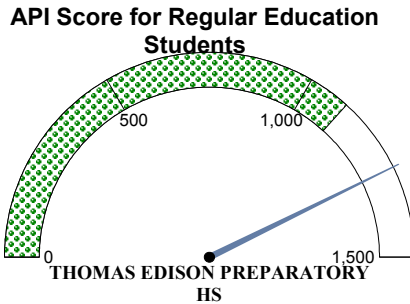

Academic Performance Index (API) and Accountability Data

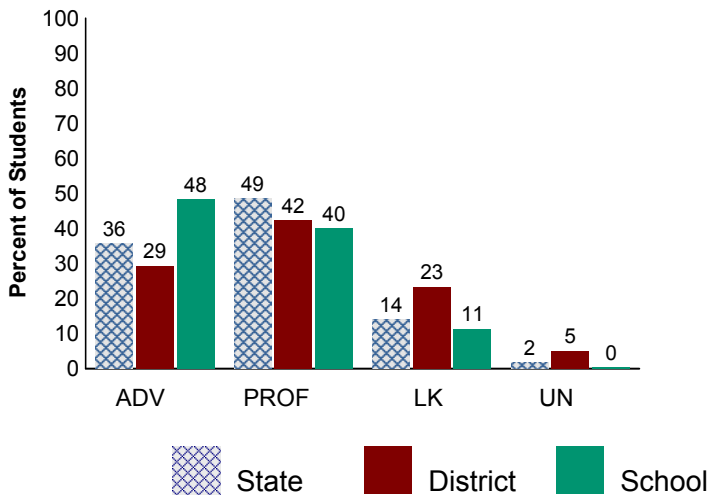

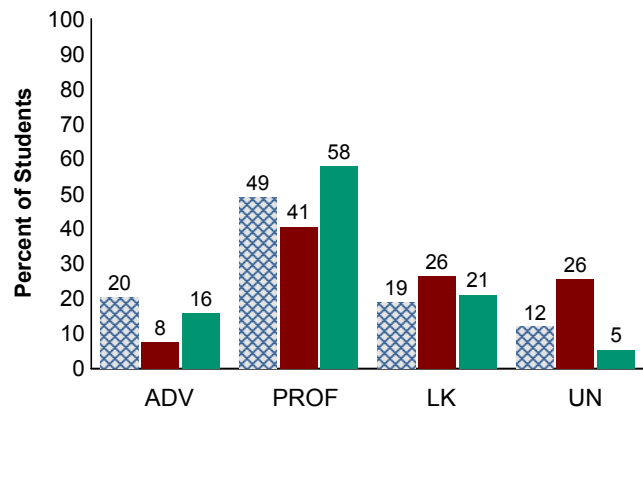
State, District and School English II Results

All Students Tested



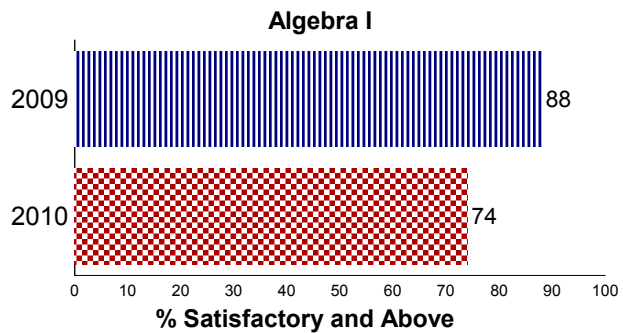
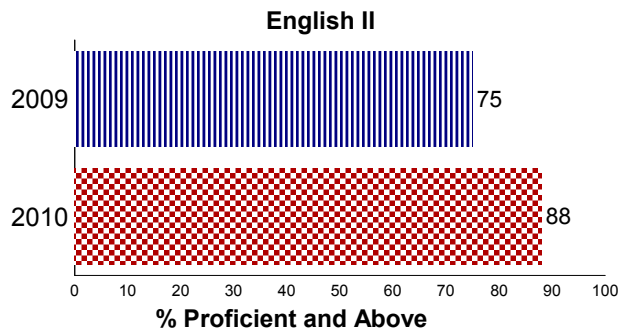
State, District and School Algebra I Results
