Position Summary: The school psychologist performs many tasks to include serving as the qualified examiner, serving as the district official in meeting IDEA policies and meeting the district's obligation of Child Find. The school psychologist administers individualized comprehensive assessments and provides interpretation for all disability categories as determined by OSDE policies and procedures. The school psychologist will ensure students reach their academic, social, emotional and physical potentials either through direct

assessment or therapy with the student(s) or indirect interventions when working with teachers and parents.

Minimum Qualifications:

- Master's degree
- Current Oklahoma teaching certification or national certification in school psychology
- Valid driver's license and reliable transportation

Responsibilities and Essential Functions: The following duties are representative of performance expectations. A reasonable accommodation may be made to enable a qualified individual with a disability to perform essential functions.

- An LEA representative, has an obligation of "Child Find" in identifying children with disabilities in need of special education services
- Utilize district guidelines, when reviewing assessment data from an outside agency or school district
- Provide consultation to colleagues and at School Psychology Case Review in the component area of Psychological, Social and Emotional
- Assure that before the consent for assessment process is initiated, the Child Study Team has implemented targeted interventions with a response to intervention
- Guide child study team through the individual evaluation process by providing input into what evaluations needs to be a part of the testing when the team determines testing is necessary.
- Complete components of a comprehensive assessment as required by district policies in a professional manner and by established timelines
- Serve as the qualified examiner on the multidisciplinary evaluation and eligibility Group Summary (MEEGS) Team and explains the assessment, disability criteria and qualifications when needed
- Prepare and process special education eligibility component of the (MEEGS)
- Provide intervention strategies, consultation services or direct or group counseling for children on IEP's to ensure students reach their academic, social, emotional and physical potentials. Submits weekly calendar/schedule per established procedures
- Attend district, departmental and staff meetings when required
- Assist with in-service training of school personnel when requested
- Complete appropriate paperwork, reports including Medicaid billing
- Display ability to work collaboratively with others on a team
- Perform other tasks, duties, or services consistent with this position as assigned

Skills and Abilities Required: The following characteristics and physical skills are important for the successful performance of assigned duties.

- Ability to engage successfully with children
- Effective oral and written communication skills
- Ability to multi-task and complete tasks within determined timelines
- Ability to translate established department and district goals into everyday work activities
- Ability to consistently implement district special education policies and procedures

- Ability to maintain confidential information consistent with the state department of special education office norms
- Ability to utilize computers efficiently and learn varied assessment specific programs
- Ability to follow standardization requirements of individualized assessments
- Ability to follow directions and guidelines as presented by the lead school psychologist
- Ability to travel from site-to-site and carry professional materials
- Ability to lift and move a minimum of ten pounds from vehicle to specified work area at each site
