Position Summary: Responsible for the general cleanliness and appearance of the entire facility. He/she will make continuous checks of the building and grounds, keeping the principal informed of any deficiencies. Maintenance of the building, of any repairs that are beyond the

BGSS's capability, will be turned into the Maintenance work order desk for emergencies, or by RQ and reported to the principal. He/she will maintain intercommunication with the Night Custodian(s) on any problems relating to the cleanliness and appearance of their respective area(s). He/she may be responsible for maintaining a current city license to operate the boiler and to maintain the swimming pool if applicable. This job requires considerable liaison with the Administrators and School District Personnel as well as the community.

Minimum Qualifications:

- High school diploma or equivalent
- Good interpersonal and organizational skills
- Computer skills and ability to communicate on a professional level (verbal and written)

Essential Job Functions:

- Responsible for training employees to perform their daily task.
- Responsible for assuring that supplies, tools and equipment are on hand to clean and maintain the school on a daily and project basis.
- Monitor, inspect and document custodial performance (discuss with supervisors)
- The Custodial staff is well versed and trained on departmental and district policies and procedures.
- The Custodial staff receives the appropriate safety training and enforces these programs.
- Quality assurance programs are effectively implemented to insure the quality standards expected.
- Maintain accurate sign-in and payroll records on all custodial staff.
- Keep an up-to-date maintenance log on all work orders open and complete.
- Keep appropriate logs on boilers, univents, pumps, pools and other equipment.

Other Non-Essential Job Functions:

- Sweeping and mopping.
- Dumping trash.
- Climbing ladders.
- Cleaning windows.
- Lift up to 50+ pounds with assistance.
- Moving furniture.
- Unlocking and removing chains from all doors.
- Turning on lights.
- Firing, checking and maintaining the boiler as required.
- Turning on the air conditioning.
- Monitor, cleaning and maintaining the swimming pool.
- Cleaning and/or monitoring an assigned area.
- Raising the flags.
- Taking out the mail.
- Policing the grounds.
- Checking the play grounds and equipment for safety concerns.
- Replacing light bulbs.
- Checking fire extinguishers.

- Cleaning the kitchen and/or cafeteria.
- Cleaning the sidewalks and entrances of ice and snow.
- Replacing filters.
- Calling in/turning in maintenance work orders.
- Filling out weekly and monthly inspection reports.
- Provide Custodial staff with current work schedules.
- Document all training and counseling.
- Visit with site administrators on regular bases.
- Meet with Supervisors, Health Department officials, Fire Marshall, Insurance Inspectors and any other agent as need.
- Organize summer clean up and any other cleaning projects as needed.
- Other duties as assigned by the Plant Operations Manager, principals and/designee.

Skills and Abilities Required: The following characteristics and physical skills are important for the successful performance of assigned duties.

- 3rd Class Engineers License

Supervisory Responsibility: Supervise the custodial staff.

Working Conditions: Exposure to the following situations may range from rare to frequent based on circumstances and factors that may not be predictable.
